In 2016 we celebrate both our 50th anniversary from when the first shipment of iron ore left Dampier and our 43-year partnership with China.

In 1973, we sent our first shipment of iron ore to Shanghai Number One Steel Mill, which is now a part of the Baosteel Group.

Over the decades together we have built not only commercial relationships, but also personal ones.

With strong support from the Australian and Chinese Governments, the original Channar joint venture was signed in 1987 and provided for the production of 200 million tonnes of iron ore. It was later extended by 50 million tonnes.

We place immense value on our long-term customer relationships and our 2016 Channar Joint Venture extension earlier this year clearly demonstrates that Rio Tinto and Sinosteel remain committed to a mutually beneficial partnership.

The Bao-HI partnership was formed in 2002, between our business and Baosteel. Over the years the joint venture has delivered hundreds of millions of tonnes to China, underpinning infrastructure growth and the metal intensive needs of its urban populations.

I am very pleased that we have been able to contribute to the enduring relationship – between our industries and between Australia and China.

We have come a long way on the path we embarked upon all those decades ago in the Pilbara. The terrain has sometimes been rocky, but we've helped and supported one another as we have progressed.

I am confident our journey together will continue, as will the relationships and bonds we have built over the past half century.

The development of the Pilbara over the last five decades is inseparable from the rapid growth of Chinese steel industry. Back in 1973, a ship carrying 21,812 tonnes of iron ore from Pilbara set sail to Shanghai, marking the very first step of cooperation between Rio Tinto and steel enterprises in China. The buyer was the Shanghai Number One Steel Company, which was later on incorporated into Baosteel Group.

A message from the Australian Ambassador to China

I congratulate Rio Tinto Iron Ore on reaching its 50th anniversary.

Being in business for 50 years is a significant milestone for any company, and this achievement is a testament not only to the quality of Rio Tinto's products, but to the long-term commitment the company has made to its staff, business partners, customers and shareholders.

It is difficult to overstate the importance of these relationships in China. Rio Tinto has been a pioneer in doing business with China. In 1973 it became the first foreign company to supply iron ore to China, shipping 22,000 tonnes from Western Australia to Shanghai Number One Steel Mill, now a part of Baosteel.

In 1987 Rio Tinto became the first foreign company to enter into a resources joint venture with a Chinese company through the Channar iron ore project with Sinosteel. In April this year in Beijing, Australian Prime Minister Malcolm Turnbull and Chinese Premier Li Keqiang witnessed the signing of the latest extension of this partnership.


Importantly, Rio Tinto's relationships in China extend well beyond the sale of resources. In recent years we've seen the increasing supply by Chinese companies of mining and railway equipment to Rio Tinto's Australian operations. Rio Tinto has strategically partnered with Chinalco, and with Tsinghua University in an Energy and Sustainable Development Joint Research Centre.

Trade and investment in resources and energy, and in particular iron ore, are fundamental to the bilateral relationship between Australia and China. Of our total two-way trade of over \$155 billion in 2015, iron ore alone was worth close to \$40 billion.

Australia is deeply committed to continuing to develop and expand its trade and investment ties with China, both in the resources sector and beyond. The entry into force of the China Australia Free Trade Agreement has brought new impetus to this vibrant and complementary bilateral relationship. We look forward to working with all of our Chinese partners to realise these opportunities.

I commend Rio Tinto Iron Ore on its dedication to its business and wider partnerships in China, and I wish the company continued success as an important contributor to the bilateral relationship between Australia and China.

更重要的是,力拓与中国的关系不止于资源贸易关系。近年来,我们看到越来越多的中国企业向力拓在澳大利亚的运营单位供应采矿、铁路等相关设备。力拓还与中铝建立了战略合作伙伴关系,并与清华大学共同成立了清华力拓资源能源与可持续发展研究中心。

以铁矿石为代表的资源能源贸易与投资,对中澳两国双边关系至关重要。 2015年,中澳两国双边贸易额达到1550 亿澳元,其中仅铁矿石贸易额就接近 400亿澳元。 澳大利亚坚定地致力于发展和扩展在资源及其他行业与中国的贸易投资关系。中澳自由贸易协定的生效又为两国充满活力和互补的双边关系注入了新的动力。我们期待着与所有的中方伙伴开展合作,充分利用中澳自由贸易协定所带来的机遇。





Musical performances

Australian Aboriginal people have been living in the Pilbara for more than 50,000 years. Their dance and songs have been passed on from generation to generation dating back to a time long before explorers and prospectors started to search the earth for its iron ore riches.

Each song, like each design or painting is part of a moment in a larger story. Songs make up a song series or a 'songline' which is a map of the country based on the travels of the Dreaming ancestors. The didgeridoo is possibly the world's oldest musical instrument and is made from tree limbs and trunks hollowed out by termites (insects) creating a wind instrument.

澳大利亚土著人民已经在皮尔巴拉地区 生活了50,000多年。土著人民的舞蹈和 歌曲代代相传,其悠久的历史远远早于 人们在这里勘探铁矿的历史。

每一首歌,就如每一种设计或每一幅画一样,都代表着一个完整故事中的某个时刻。不同歌曲组成的组曲,就好像是由"梦创时期"的土著祖先们的足迹绘制出的地图。土著人使用的迪吉里杜管或许是世界上最古老的乐器,这种管乐器由树枝以及被白蚁蛀空的树干制作而成。

Olman Walley is an acclaimed traditional Aboriginal dancer, didgeridoo player, actor and poet. Olman is descended from the Noongar people, and has connections to six of the 14 Traditional Owner groups, who originate from the south west of Western Australia.

A Welcome to Country is an important ceremony by Aboriginal people which is an acknowledgment of respect for the traditional owners.

Voyager Estate

航海家酒庄

The beautiful Voyager Estate wines featured at the 50th dinner are from Margaret River, a world-class wine region located in Western Australia. Owned by the Wright family, Voyager Estate's connection to Rio Tinto dates back to the 1960s. It was the partnership between Western Australian-born prospector and pastoralist Lang Hancock and businessman Peter Wright, which persuaded the then London-based Rio Tinto to take an interest in the iron ore deposits of the Pilbara.

Lang and Peter undertook further work with Thomas Moore Price, an engineer and raw minerals expert, with his remarkable character, imagination and expertise proving instrumental in assisting the formation of Hamersley Iron. The town of Tom Price in the Pilbara is named after him and, in recognition of his contribution to Western Australia's iron ore industry, Voyager Estate has named a special range of fine wines in his honour.

此美酒产自航海家酒庄,该酒庄位于西澳州玛格丽特河地区,是世界一流的葡萄酒产地。

航海家酒庄现由莱特家族掌管,其与力拓的渊源可以追溯到上世纪60年代。当时,西澳州牧民探矿者朗·汉考克与商人彼得·莱特合作,共同说服了总部位于伦敦的力拓公司对西澳州皮尔巴拉地区的铁矿矿藏进行投资。

汉考克和莱特后来又与工程师、矿物原料专家汤姆·普莱斯展开合作。人们公认汤姆·普莱斯的人格魅力、远见卓识以及专业水平对哈默斯利铁矿公司的成立起到了至关重要的作用。

皮尔巴拉地区的汤姆普莱斯镇就是以普莱斯先生的名字命名的。为了纪念他对西澳州铁矿事业做出的贡献,航海家酒庄也以他的名字为一系列美酒命名。
